- 1.3. Acquaint myself each year/semester, with all the Rules and general Regulations including class, residence and other relevant fee increase that relate to the programme for which I am applying.
- 1.3.1. I hereby undertake to acquaint myself, abide by and comply with ECOT statutes, all the rules, regulations, policies and procedures of the Institution as amended from time to time.
- 1.3.2. I agree that the Institution, through the Educational policy, Higher Educational Bill and its normal Governance bodies may amend any Regulation, Policy or Procedure and that I shall be bound to any such amendment as soon as it may take effect.
- 1.4. Make alternate arrangements for accommodation should the College accept me for a Degree/Diploma and cannot offer me Accommodation.

- 6.2. I warrant that the information contained herein is true and correct and the Institution shall be entitled to declare the contract void and cancel my registration if I have made any misrepresentation or omission on this application.
- 6.3. Foreign Students:
- 6.3.1. I am aware that I am responsible to renew my study permit three (3) months prior to the expiry date.
- 6.3.2. Refugee: I am aware that I am responsible to renew my study permit one (1) month prior to its expiry date.
- 7. I hereby absolve the Institution, its Staff, Employees, Representatives and/or agents from any claims which I/the student may acquire as a result of any injuries which I/the student may receive and/or damages which I/the student may suffer as a result of any happening, incident, accident, injury, illness or death, however it may have resulted, or as a result of my/his/her participation in any Sport/excursion/visit or transport which may take place during my/his/her studies at the Institution.
